**RESOLUTION GIVING INDIVIDUAL COUNTY BOARD MEMBERS AUTHORITY  
TO SELECT AN ALTERNATE COUNTY BOARD MEMBER TO ATTEND  
COMMITTEE, BOARD AND OTHER ORGANIZATIONAL MEETINGS**

WHEREAS, the Yellow Medicine County Board annually appoints county board members to represent Yellow Medicine County on committees, boards and other organizations associated with the County; and

WHEREAS, there are times when the appointed county board member cannot attend a committee, board or organizational meeting that is scheduled; and


WHEREAS, the County Board believes it is important to have a county board member attend said meetings whenever possible; and

WHEREAS, the past practice for county board members has been to ask another member of the county board to attend a meeting in their absence and on behalf of the Yellow Medicine County.

THEREFORE, BE IT RESOLVED, that the Yellow Medicine County Board of Commissioners shall continue with the past practice of giving individual county board members authority to select an alternate county board member to attend committee, board and other organizational meetings in the appointed board member's absence and on behalf of Yellow Medicine County.
