Motion carried with Commissioner Berends, Renneke and Kack voting in favor and Commissioner Johnson abstaining due to a conflict of interest.

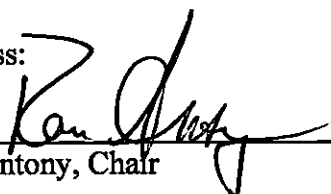
