Chairman John Berends called this regular meeting of the Yellow Medicine County Board to order at 9:00 a.m. with Commissioners Ron Antony, Mitch Kling, Greg Renneke and Glen Kack also present. Also present were County Administrator Angie Steinbach, County Attorney Mark Gruenes and HR Manager Ashley Soine.

Approval of Agenda 05-13-25-01 Motion by Commissioner Kling and seconded by Commissioner Kack to approve the agenda. Motion carried with all voting in favor.

Consent Agenda 05-13-25-02 Motion by Commissioner Antony and seconded by Commissioner Kling to approve the consent agenda items as follows: April 22, 2025 County Board meeting minutes; Pay Application No. 13 from KUE Contractors, Inc. in the amount of \$324,279.65; approval of liquor license for Canby Golf Course; resignation of Jarrod Flinn, Correctional Officer/Dispatcher; replace Correctional Officer/Dispatcher position; hiring of Tyden Marczak for the Seasonal Parks Maintenance position, his salary will be grade 4, step 1, his start date is May 19, 2025. Motion carried with all voting in favor.

Dan Moravetz, County Engineer, discussed an option from MnDOT regarding a lighting enhancement at a specific intersection. The consensus was to notify MnDOT to move forward if they agree to pay all costs now and in the future.

Quotes for Patching on CSAH 39 05-13-25-06 Motion by Commissioner Antony and seconded by Commissioner Kling to approve the low quote from Central Specialties, Inc. in the amount of \$30,000 for patching on CSAH 39. Two other quotes were received. Motion carried with all voting in favor.

Fairgrounds Property Management Proposals 05-13-25-07 Motion by Commissioner Kling and seconded by Commissioner Renneke to approve the low proposal from EMK Properties LLC in the amount of \$5,500 for Fairgrounds Property Management duties from June 1, 2025 to May 31, 2026. Three other proposals were received. Motion carried with all voting in favor.

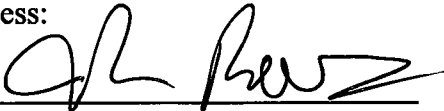

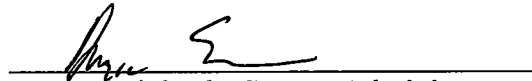
