October 14, 2025**

Approval of Agenda 10-14-25-01 Motion by Commissioner Antony and seconded by Commissioner Kack to approve the agenda. Motion carried with all voting in favor.

Approval of Disbursements/Review Auditor's Warrants 10-14-25-03 Motion by Commissioner Kack and seconded by Commissioner Antony to approve the commissioner warrants for the following amounts: \$138,817.51 Ditch Fund, \$176,692.42 Revenue Fund, \$24,561.28 Road & Bridge Fund, \$150,227.24 Human Services Fund; and acknowledged review of the Auditor's warrants. An itemized listing of all warrants over \$2,000 and an aggregate total for warrants under \$2,000 are published on the County website under the Finance & Administration Department. Motion carried with all voting in favor.

AC Machine 10-14-25-07 Motion by Commissioner Renneke and seconded by Commissioner Kack to approve the low quote from RSS Group International, Inc. in the amount of \$8,690 for the purchase of a CPS MSX 3080 Dual AC Machine. Motion carried with all voting in favor.
