**JD 21 Branch 12 Cleaning 09-25-18-07** Motion by Commissioner Berends and seconded by Commissioner Kack to approve the low bid from Barker Excavating in the amount of \$13,395 for the cleaning of JD 21 Branch 12. Two other bids were received. Motion carried with all voting in favor.

CD 3 Cleaning 09-25-18-08 Motion by Commissioner Kack and seconded by Commissioner Berends to approve the low bid from Barker Excavating in the amount of \$14,000 for the cleaning of CD 3. Two other bids were received. Motion carried with all voting in favor.
